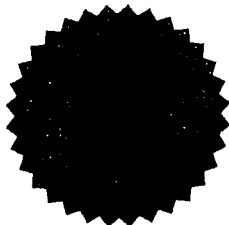

Pursuant to Section 263 of the General Corporation Law of the State of Delaware (the "DGCL"), Informatics Acquisition, Inc., a Delaware corporation (the "Company"), in connection with the merger of Informatics, Ltd., a Texas limited partnership ("Informatics Ltd.") with and into the Company (the "Merger"), hereby certifies as follows:

FIFTH. The Merger shall become effective at 12:02 A.M. on March 25, 2005.


