Pursuant to the merger of BV Acquisition, Inc. with and into Best Value Textiles, Inc. and in accordance with Sections 7-90-301 et seq. and 7-110-107 of the Colorado Revised Statutes, the Articles of Incorporation of the Surviving Corporation shall be amended and restated in the form set forth below:

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

BEST VALUE TEXTILES, INC.

These Amended and Restated Articles of Incorporation shall supersede and replace the heretofore existing Articles of Incorporation, and all amendments thereto, of Best Value Textiles, Inc., a Colorado corporation (the "Corporation").

ARTICLE I. NAME

The name of the Corporation is Best Value Textiles, Inc.

ARTICLE I. PRINCIPAL OFFICE

The principal office and principal mailing address of the Corporation is 555 Koopman Lane, Elkhorn, Wisconsin 53121.

ARTICLE III. REGISTERED OFFICE AND AGENT
