TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") is by and between Science Applications International Corporation, a Delaware Corporation ("Assignor") and wholly-owned subsidiary of SAIC, Inc., a Delaware corporation (the "Company" or "Leidos"), and SAIC Gemini, Inc., a Delaware corporation ("New SAIC" or "Assignee"), effective as of September 27, 2013 (the "Effective Date").

WHEREAS, the Board of Directors of the Company has determined that it is appropriate, desirable and in the best interests of the Company and its stockholders to separate the Company into two separate, publicly traded companies (the "Separation"), pursuant to and in accordance with the Distribution Agreement dated as of the date hereof, by and between Leidos and New SAIC (as such may be amended from time to time, the "Distribution Agreement");

WHEREAS, in connection with the Separation, Assignor wishes to assign to Assignee its rights in and to the trademark applications, trademark registrations, and common law trademarks listed on Schedule A;

NOW, THEREFORE, in consideration of the promises and of the mutual covenants and agreements herein contained, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title, and interest in and to the trademark applications, trademark registrations, and common law trademarks listed on Schedule A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, the rights of renewal thereof, all common law rights related thereto, and any rights of Assignor to sue for and recover any profits, penalties, expenses and other damages arising out of or related to any past, present, and/or future infringement, dilutions, or violations thereof (collectively, the "Trademarks").

2. The right, title, and interest in and to each of the Trademarks are to be held and enjoyed by Assignee as fully and exclusively as they would have been held and enjoyed by Assignor had this assignment not been made.

3. This Assignment has been executed and delivered for the purpose of recording this Assignment with the United States Patent and Trademark Office or any other applicable office. This Assignment has been executed and delivered in connection with the Distribution Agreement. Assignee shall be responsible for any filings, fees or other expenses required to record, perfect, validate, or effectuate this Assignment.

4. Assignor shall, at Assignee's expense, promptly sign, execute, and deliver any documents provided by Assignee and take all further action that may be reasonably required for recording this Assignment in any applicable office.


5. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall, taken together, be considered one and the same agreement.





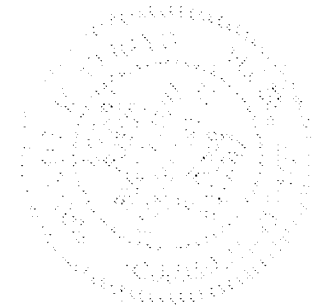
