**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of October 11, 2013, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as Collateral Agent (the “**Agent**”) in favor of El Pollo Loco, Inc. (the “**Pledgor**”). Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement (as defined below).

WHEREAS, the Pledgor issued 17% Second Priority Senior Secured Notes due 2018 (“**Notes**”) pursuant to that certain Indenture, dated as of July 14, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the “**Indenture**”), among the Pledgor, the Parent, the other guarantors party thereto and the Agent, as Trustee, pursuant to which the Pledgor, the Parent and the other guarantors party thereto guaranteed the payment of all of the principal of and interest and premium on the Notes;

WHEREAS, in order to secure (i) the payment of all of the principal of and interest and premium, if any, on the Notes and the payment and performance of all other Obligations and (ii) all of the Pledgor’s and other guarantors’ obligations and liabilities thereunder and in connection therewith, the Pledgor and other guarantors party thereto were required to execute and deliver that certain Security Agreement, dated as of July 14, 2011 among the Pledgor, the Parent, the other guarantors party thereto, and the Agent (the “**Security Agreement**”) pursuant to the Indenture;

WHEREAS, pursuant to the Security Agreement, the Pledgor granted a security interest to the Agent in the Collateral, including the Trademark Collateral and Copyright Collateral, and was required to execute (i) that certain Second Lien Trademark Security Agreement dated as of July 14, 2011 (the “**Trademark Security Agreement**”) and (ii) that certain Second Lien Copyright Security Agreement dated as of July 14, 2011 (the “**Copyright Security Agreement**”, and together with the Trademark Security Agreement, the “**IP Security Agreements**”);

WHEREAS, pursuant to the Trademark Security Agreement, the Pledgor granted to the Agent, for the benefit of the Secured Parties, a security interest in and continuing lien on all of the Pledgor’s right, title and interest in, to and under the Trademark Collateral, including, but not limited to the registrations and applications referred to in Schedule A attached hereto;

WHEREAS, pursuant to the Copyright Security Agreement, the Pledgor granted to the Agent, for the benefit of the Secured Parties, a security interest in and continuing lien on all of the Pledgor’s right, title and interest in, to and under the Copyright Collateral, including, without limitation, the registrations and applications referred to in Schedule B attached hereto;

WHEREAS, (i) the Trademark Security Agreement was recorded with the Trademark Division of the U.S. Patent and Trademark Office on July 19, 2011 at Reel/Frame No. 4586/0500 and (ii) the Copyright Security Agreement was recorded with the U.S. Copyright Office on July 20, 2011 at Volume 3606, Document 46;

WHEREAS, the Agent has been requested by the Pledgor to release in its entirety its security interest in and continuing lien on all of the Pledgor’s right, title and interest in, to and under (i) the Trademark Collateral, including, but not limited to the registrations and applications referred to in

Schedule A attached hereto and (ii) the Copyright Collateral, including, without limitation, the registrations and applications referred to in Schedule B attached hereto.

NOW THEREFORE, for good and valuable consideration, including the satisfaction of all of the Pledgor's payment obligations, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby releases and terminates all of its security interest in and continuing lien on all of the Pledgor's right, title and interest in, to and under (i) the Trademark Collateral, including, but not limited to the registrations and applications referred to in Schedule A attached hereto and (ii) the Copyright Collateral, including, without limitation, the registrations and applications referred to in Schedule B attached hereto, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral and Copyright Collateral to the Pledgor.

"Trademark Collateral" shall mean:

- a) Trademarks of the Pledgor, including the United States registered Trademarks and applications for Trademark registration, listed on Schedule A attached hereto; and
- b) all Proceeds of any and all of the foregoing.

"Copyright Collateral" shall mean:

- a) Copyrights of the Pledgor, including such United States registered copyrights and exclusive licenses of copyrights listed on Schedule B attached hereto; and
- b) all Proceeds of any and all of the foregoing.

2. The Agent hereby authorizes and requests that the Commissioner for Trademarks, the Registrar of Copyrights and any other applicable government officer record this Release.

3. The Agent agrees, at the Pledgor's expense, to cooperate with the Pledgor and to provide the Pledgor with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

4. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Release by facsimile or other electronic submission will be as effective as delivery of a manually executed counterpart of this Release.

5. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
