RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of October 16, 2013, is made by FSJC XIV, LLC, as Collateral Agent for itself and certain lenders ("Secured Party").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated July 19, 2012, GERBER CHILDRENSWEAR LLC and HANNA ANDERSON, LLC (collectively, the "Grantor") granted to Secured Party a security interest in certain registered trademarks of Grantor, which registered trademarks are more fully identified on Schedule A annexed hereto and made a part hereof (the "Subject Trademarks").

WHEREAS, Secured Party's security interest was recorded with the United States Patent and Trademark Office ("USPTO") by Grantor's filing of that certain Grant of a Security Interest – Trademarks ("Trademark Filing"), which was recorded with the USPTO on July 31, 2012, at Reel 004832, Frame 0499.

NOW THEREFORE, Secured Party hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges Secured Party's security interest in, lien on, and conditional assignment of the Subject Trademarks, together with, among other things, the goodwill of the business symbolized by the Subject Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Collateral"), and Secured Party hereby reassigns to Grantor any and all such right, title and interest (if any) that the Secured Party may have in the Collateral. Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Collateral and the termination of the Trademark Filing. This Release shall be governed by and construed in accordance with the laws of the State of New York.
