**RESOLVED**, that Article I of the Amended and Restated Certificate of Incorporation of the Corporation be amended to read in its entirety as follows:

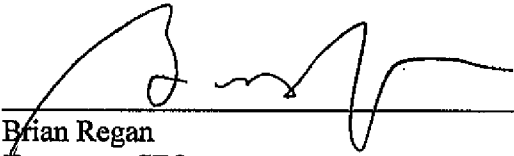
**"ARTICLE I**
