LIMITED RELEASE OF SECURITY INTEREST

THIS LIMITED RELEASE OF SECURITY INTEREST (the "Release") is made as of this 26th day of February, 2010, by Sam Houser, an individual, solely in his capacity as agent ("Agent") for the benefit of Another Game Company LP, a Delaware Limited Partnership, Leslie Benzies, an individual, Sam Houser, an individual and Dan Houser, an individual (collectively, the "Secured Parties") pursuant to that certain Security Agreement, dated as of March 13, 2009, by and among Take-Two Interactive Software, Inc., a Delaware corporation ("Take-Two") and Rockstar Games, Inc., a Delaware corporation, as debtors, the other grantors listed on the signature pages thereto and those additional entities that may become party thereto from time to time, as guarantors and the Secured Parties (as amended and as may be further amended or modified from time to time, the "Security Agreement"). Capitalized terms that are not otherwise defined herein shall have the meanings ascribed to such terms as set forth in the Security Agreement.

WHEREAS, concurrently with the execution of the Security Agreement, Take Two and the Secured Parties entered into that certain Trademark Security Agreement, dated as of March 13, 2009 (as amended and as may be further amended or modified from time to time, the "Trademark Security Agreement") in favor of the Secured Parties;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel/Frame 3957/0417;

WHEREAS, pursuant to the Trademark Security Agreement, Jack of all Games, Inc., a New York corporation ("JOAG") granted to the Secured Parties a continuing security interest in its right, title and interest in and to certain trademark registrations and applications; provided, however, that under the Security Agreement and Trademark Security Agreement, any assets sold


to a Person who is not a Grantor and is not required to become a Grantor thereunder in an arms length transaction are not Collateral pursuant to the Security Agreement and Trademark Security Agreement;

WHEREAS, as of the date hereof, JOAG has sold certain assets to a Person who is not a Grantor and is not required to become a Grantor under the Security Agreement and Trademark Security Agreement, including those trademark registrations and applications listed on Exhibit A attached hereto and made a part hereof (the "Released Collateral").

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which is hereby acknowledged, Sam Houser, solely in his capacity as Agent for the Secured Parties, hereby unconditionally and expressly (i) releases and terminates its security interest (if any) in and to the Released Collateral and any goodwill associated therewith, (ii) assigns any such right, title and interest it may have in the Released Collateral (if any) to JOAG and (iii) authorizes JOAG or any of its designees, including any transferee of the Released Collateral to instruct and authorize all applicable government officers to record this Release, including but not limited to recording the termination and release of the Secured Parties' security interest (if any) in the Released Collateral. The Secured Parties hereby solely release their lien and security interest (if any) solely in the Released Collateral and no other assets.
