TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of 22 Oct. 2013, 2013, is made by and between Martin Archery, Inc., a Washington corporation ("Assignor"), and Martin Sports Inc., a Washington corporation ("Assignee").

A. Assignor did and hereby does assign, sell, transfer and convey, free and clear of any liens, to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademarks throughout the world, including without limitation all trademark applications and registrations therefor, all common law rights in such Trademarks, all goodwill of the business symbolized by the Trademarks, as well as the right to sue and to collect all damages and payments for claims of past, present and future infringement or misappropriation thereof and all other corresponding rights that are or may be secured under the laws of the United States and any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the registered Trademarks.

2. Upon the request of Assignee, Assignor agrees for itself and its successors, representatives and assigns, to perform such lawful acts and to sign such further applications, assignments, statements and other lawful documents as Assignee may reasonably request to effectuate fully the assignment and the purposes set forth herein.
