

AND the Intermediary, on behalf of itself and its executors and administrators, hereby covenants and agrees to do all such lawful acts and things and to execute without further consideration such further lawful assignments, documents, assurances, applications, and other instruments as may reasonably be required by said Assignee, its successors, assigns or legal representatives, to vest the Trade Marks in said Assignee, its successors, assigns or legal representatives.






