TRADEMARK ASSIGNMENT (NUNC PRO TUNC)

Assignor has agreed to and does hereby sell, assign, transfer, and convey unto Assignee, and its successors, assigns, and legal representatives, all right, title, and interest in, to, and under the Trademarks together with all common law rights and all goodwill of the business in connection with which the Trademarks are used, as well as all claims for damages by reason of past infringement of the Trademarks with the right to sue for and collect damages, to be held and enjoyed by Assignee, its successors, assigns, and legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor had this sale, assignment, transfer, and conveyance not been made.

Assignor agrees that, when requested, it will sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable, or convenient for securing and maintaining the Trademarks in all countries and for vesting title thereto in Assignee, its successors, assigns, and legal representatives or nominees.

Assignor covenants to Assignee, its successors, assigns, and legal representatives that the interest and property hereby conveyed are free from all prior assignment.
