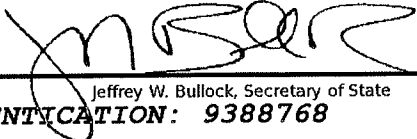

**SECOND:** The corporation hereby amends its Certificate of Incorporation as follows:

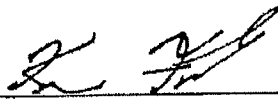
