2. Article 1 of the Restated Articles of Incorporation of the corporation is amended to read in its entirety as follows:

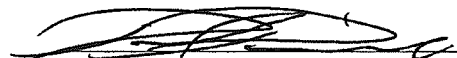
Article 1

The name of the corporation is Microsemi SoC Corp.

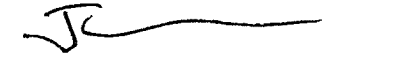
3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the board of directors of the corporation.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.

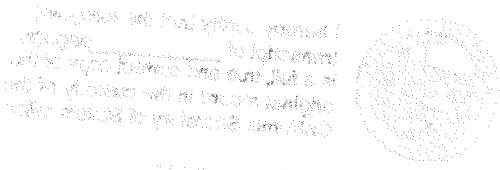
