## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of October 28, 2013, by JPMorgan Chase Bank, N.A., as Administrative Agent (the “Administrative Agent”) to Jobsinthemoney.com, Inc. (the “Obligor”) as follows:

WHEREAS, the Obligors (each an “Obligor” and collectively, the “Obligors”) and the Administrative Agent for the holders of the Secured Obligations are parties to that certain Security and Pledge Agreement dated as of June 14, 2012 (as may be amended, modified, extended or restated from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Obligor was required to execute and deliver a Notice of Grant of Security Interest in United States Trademarks dated as of June 14, 2012 (the “Trademark Agreement”) to the Administrative Agent in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Trademark Agreement, the Obligor granted to the Administrative Agent on behalf of the holders of the Secured Obligations, among other collateral, a continuing security interest in all of the Obligor’s right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Marks”);

WHEREAS, the Trademark Agreement was recorded in the United States Patent & Trademark Office on June 15, 2012 at Reel/Frame 4802/717; and


WHEREAS, the Administrative Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Obligor has satisfied its Secured Obligations under the Security Agreement, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Obligor any and all right, title or interest in, or to, the Marks that the Administrative Agent may hold.
