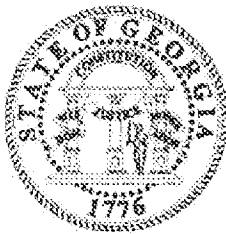


1. The name and jurisdiction of organization of each of the merging entities are as follows:

7. The Plan of Merger has been duly authorized and approved by each of the merging entities in accordance with O.C.G.A. § 14-11-903.






