RELEASE OF TRADEMARK SECURITY INTEREST

FOR VALUE RECEIVED, the undersigned, GENERAL ELECTRIC CAPITAL CORPORATION, as Administrative Agent (the "Secured Party"), does hereby re-grant, re-assign, re-transfer and re-convey absolutely, and terminate and release any Lien on and security interest in and to the Trademark Collateral (as defined below), granted and pledged to it by AMNEAL PHARMACEUTICALS LLC, a Delaware limited liability company (the "Grantor"), pursuant to that certain Trademark Security Agreement, dated as of August 9, 2011 and that certain Trademark Security Agreement, dated as of December 7, 2012, each between Secured Party and Grantor (collectively, the "Security Agreements"), and re-assigns the Trademark Collateral to Grantor. Such re-grant, re-assignment, re-transfer and/or re-conveyance by the Secured Party is made WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE.

As used herein, the term "Trademark Collateral" has the meaning set forth in the Security Agreements, and includes, without limitation, (i) the trademarks and trademark applications listed on Exhibit A hereto, (ii) all renewals thereof, (iii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof, (v) all rights corresponding thereto throughout the world, (vi) all goodwill of the Grantor's business connected with and symbolized by such trademarks and (vii) the Security Agreements as recorded on behalf of Secured Party by the United States Patent and Trademark Office on August 9, 2011 at Reel 4600, Frame 0515 and on December 8, 2012 at Reel 4915, Frame 0436.

The Secured Party shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this release.
