

TRADEMARK ASSIGNMENT

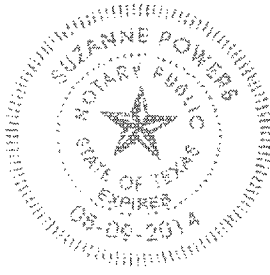
