RELEASE OF TRADEMARK SECURITY INTERESTS, dated as of March 22, 2010 (this "**Release**"), by CREDIT SUISSE AG (formerly known as Credit Suisse First Boston), as collateral agent (in such capacity, the "**Collateral Agent**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of August 2, 2004 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Alion Science and Technology Corporation (the "**Borrower**"), the lenders from time to time party thereto and Credit Suisse AG, as Administrative Agent and as Collateral Agent, (ii) the Guarantee and Collateral Agreement dated as of August 2, 2004 (as amended, supplemented or otherwise modified from time to time, the "**Guarantee and Collateral Agreement**"), among the Borrower, the subsidiaries of the Borrower party thereto and the Collateral Agent and (iii) the Trademark Security Agreement dated as of June 30, 2006, among Alion-MA&D Corporation ("**MA&D**" and, together with the Borrower, the "**Grantors**") and the Collateral Agent (such documents set forth in clauses (i) through (iii), the "**Security Agreements**").

B. Pursuant to the Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Grantors in the Trademark Collateral, including the trademarks of the Grantors set forth on Schedule I hereto, which security interests were recorded with the United States Patent & Trademark Office on (i) October 1, 2004 at Reel/Frame 003059/0927 and (ii) July 19, 2006 at Reel/Frame 003351/0133.

C. Pursuant to the Termination and Release Agreement dated as of March 22, 2010, among the Borrower, the Administrative Agent and the Collateral Agent, the Collateral Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. The Collateral Agent agrees to make filings with the United States Patent and Trademark Office and other necessary filings, in each case reasonably requested by the Borrower and at the expense of the Borrower, to evidence the release and termination of the Collateral Agent's security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
