**RELEASE OF SECURITY INTEREST**

This Release of Security Interest is made as of October 31, 2013 by MAT Investments, LLC (the "Secured Party") as collateral agent for the Secured Party, Big Idea Lab Generation, Inc. ("Big Idea") and Jason Stanson ("Stanson", and together with Secured Party and Big Idea, the "Lenders").

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of September 28, 2012 (as supplemented and/or amended from time to time, the "Security Agreement"), Sazzi Footwear, LLC, a California limited liability company ("Grantor"), granted to the Secured Party, as collateral agent for the Lenders, a security interest in certain assets of Grantor, including in all intellectual property of Grantor (including but not limited to the Listed Intellectual Property in Exhibit A hereto); and

WHEREAS, pursuant to that certain Loan Settlement and Membership Redemption Agreement of even date herewith, the obligations by and among Grantor and Secured Party, Big Idea, and Stanson have been settled; and

WHEREAS, the Lenders have agreed to release their security interests in all of the Grantor's intellectual property, including without limitation the Listed Intellectual Property, and further including all goodwill associated with the foregoing, in the United States or foreign countries, arising out of the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders hereby release and discharge any and all security interests in any and all of the Grantor's intellectual property as set forth in the Security Agreement, including without limitation the Listed Intellectual Property, including any rights and interest they might have in the United States or foreign countries, and further including all goodwill associated with the foregoing, and hereby consent to recordation of this Release of Security Interest at the USPTO and to all other recordations, notices, filings and/or the like.
