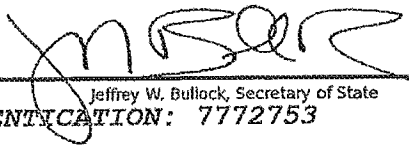



**CERTIFICATE OF CONVERSION  
FROM A CORPORATION TO A LIMITED LIABILITY COMPANY**

This CERTIFICATE OF CONVERSION (this "Certificate") is made pursuant to Section 18-204 and Section 18-214 of the Delaware Limited Liability Company Act (the "Act") and is hereby filed with the Secretary of State of the State of Delaware (the "Delaware Secretary") pursuant to Section 18-206 of the Act.

1. The name of the converting corporation immediately prior to the filing of this Certificate is Dura Operating Corp. (the "Converting Corporation").
