ASSIGNOR hereby acknowledges that this assignment, being of the entire right, title, and interest in and to the Trademark, carries with it the right in ASSIGNEE to apply for and obtain from competent authorities in all countries of the world any and all trademarks by attorneys and agents of ASSIGNEE's selection and the right to procure the registration of all such trademarks to ASSIGNEE for its own name as assignee of the entire right, title, and interest therein;

AND, ASSIGNOR hereby further agrees to execute upon request any other lawful documents and likewise to perform any other lawful acts that may be deemed necessary to secure fully the Trademark to the ASSIGNEE, its successors, assigns, and legal representatives, but at its or their expense and charges, including the execution of applications for trademark registration in foreign countries and the execution of any further applications;
