ASSIGNMENT OF TRADEMARK RIGHTS (Entire Interest)

WHEREAS, Copper River Country Club, a corporation organized and existing under the laws of the State of California and having a principal place of business of 11500 N. Friant Road, Fresno, California 93720 ("Assignee") owns an interest in U.S. Trademark Registration No. 3,039,219 for the mark COPPER RIVER for use in connection with various services listed therein (the "Mark"); and

WHEREAS, Copper West, Inc., a corporation organized and existing under the laws of South Carolina and having a principal place of business of 175 Rogers Commerce Blvd., Boiling Springs, South Carolina 29361 ("Assignor") obtained from Assignee an interest in the Mark covering only "restaurant services" in only the geographic region consisting of all of the states of the continental United States of America that are located east of the Mississippi River;

WHEREAS, Copper River Country Club is desirous of reacquiring all of Copper West, Inc.'s right, title, and interest in and to the Mark, and Copper West, Inc. is desirous of reconveying such rights back to Copper River Country Club; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all of Assignor's right, title, and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark.
