ASSIGNMENT OF TRADEMARK RIGHTS (Undivided Part Interest)

WHEREAS, Copper River Country Club, a corporation organized and existing under the laws of the State of California and having a principal place of business of 2140 E. Clubhouse Drive, Fresno, California 93730 (“**Assignor**”) is the owner of the mark COPPER RIVER (“**Mark**”) for use on or in connection with the following services, together with the goodwill associated with the use thereof, and the U.S. Federal Registration thereof (Reg. No. 3039219; the “**’219 Registration**”):

“Retail golf pro shop services featuring golf, tennis, and fitness equipment and apparel”, in Intl. Cl. 035; “Country club services; entertainment in the nature of tennis and golf tournaments; tennis instruction; golf instruction; golf courses; and physical fitness instruction”, in Intl. Cl. 041; and “Providing banquet and social function facilities for special occasions”, in Intl. Cl. 042 (hereinafter “**Part 1**”); and

“Restaurant Services”, in Intl. Cl. 042 (hereinafter “**Part 2**”);

WHEREAS, Copper West, LLC, a limited liability company organized and existing under the laws of South Carolina and having a principal place of business of 175 Rogers Commerce Blvd., Boiling Springs, South Carolina 29361 (“**Assignee**”) is desirous of acquiring rights, jointly shared with Assignor, in and to the Mark for use on or in connection Part 2 above, i.e., only with “restaurant services”, and does not desire to acquire any rights in and to the Mark for use on or in connection with Part 1 above;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign to Assignee and Assignor, as joint owners, Assignor’s right, title, and interest in and to the Mark for use on or in connection only with “restaurant services”, in Intl. Cl. 042, together with the part of the goodwill associated with the use thereof, and the part of the ‘219 Registration thereof. Assignor expressly does not assign to Assignee any right, title, or interest in and to any portion of the Mark for use on or in connection with Part 1 above, or any part of the goodwill associated with the use thereof, or any part of the ‘219 Registration thereof. Assignor shall remain the sole owner of all right, title, and interest in and to the Mark for use in connection with “Retail golf pro shop services featuring golf, tennis, and fitness equipment and apparel”, in Intl. Cl. 035; “Country club services; entertainment in the nature of tennis and golf tournaments; tennis instruction; golf instruction; golf courses; and physical fitness instruction”, in Intl. Cl. 041; and “Providing banquet and social function facilities for special occasions”, in Intl. Cl. 042, together with the part of the goodwill associated with the use thereof, and the part of the ‘219 Registration thereof.
