TRADEMARK ASSIGNMENT



1. Assignment. Assignor hereby grants, assigns and conveys to Assignee nunc pro tunc effective as of August 11, 2013, all of its right, title and interest in and to the Trademark together with the goodwill of the business symbolized by the trademark, the aforesaid Registration No. 3413058 and that portion of Assignor's business which is associated with the trademark.
2. Title. Assignor hereby represents and warrants that it has not heretofore granted any license, right or privilege with regard to the Trademark, or in any other way encumbered the same, and that it has the full right to convey, free of licenses and encumbrances, all right, title and interest in and to the Trademark.
3. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.
4. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
