**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**"), dated as of October 4, 2013, is made by Cortland Products Corp. (f/k/a Gleacher Products Corp.) (as successor to Citicorp North America, Inc.), as Administrative Agent, Term A Collateral Agent and Term B Collateral Agent (the "**Agent**"), under the Credit Agreement referred to below. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Credit Agreement.

**WHEREAS**, in connection with that certain Term Loan Agreement, dated as of June 19, 2009 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "**Credit Agreement**"), among Source Interlink Companies, Inc., a Delaware corporation (the "**Borrower**"), certain subsidiaries of the Borrower, as Guarantors, (collectively, the "**Subsidiary Guarantors**"), the Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrower;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Trademark Security Agreements**"), certain Subsidiary Guarantors granted a Lien on and security interest in all of such Subsidiary Guarantor's right, title and interest in, to and under all of the following personal property of such Subsidiary Guarantor, in each case whether now owned or existing or hereafter acquired or arising and wherever located (all of which being hereinafter collectively referred to as the "**Trademarks**"):

(a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, internet domain names, and other source or business identifiers, and, in each case, all goodwill associated therewith, (ii) all registrations, applications for registration, renewals, and recordings thereof and the right to obtain the same, in each case whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof or otherwise, including each application and registration referred to in Annex 1 attached hereto, and (iii) all common-law rights related thereto; and

(b) all rights to sue at law or in equity for any infringement, misappropriation, or other violation or impairment thereof and the right to receive all Proceeds (including, licenses, royalties, income, payments, claims, damage awards and proceeds of suit) therefrom.

**WHEREAS**, the Trademark Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its Lien on and security interest in the Trademarks, whether granted pursuant to the Trademark Security Agreements, the Pledge and Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademarks to such Subsidiary Guarantors, respectively.


