IP ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS IP ASSIGNMENT AND ASSUMPTION AGREEMENT (this "IP Assignment") is made and entered into on this 1st day of August, 2013, by and between iGPS Logistics LLC, a Delaware limited liability company ("Buyer"), and iGPS Company LLC, a Delaware limited liability company ("Seller"). Seller and Buyer are each referred to herein as a "Party," or collectively, as the "Parties."

WHEREAS, pursuant to that certain Amended Asset Purchase Agreement, dated as of July 29, 2013 (the "Purchase Agreement"), by and between Buyer and Seller, Seller has agreed to sell, assign, transfer, deliver and convey to Buyer and Buyer has agreed to purchase, acquire and accept from Seller various Purchased Assets, including without limitation, the Intellectual Property Rights of Seller, the "iGPS" name, logos and the goodwill associated therewith; and

WHEREAS, the Bankruptcy Court entered its Order (A) Approving the Agreement for the Sale and Purchase of Assets Free and Clear of Liens, Claims, Encumbrances and Interests; (B) Authorizing and Approving the Sale of Assets to iGPS Logistics LLC Free and Clear of Liens, Claims, Encumbrances and Interests; and (C) Granting Related Relief (the "Sale Order") on July 29, 2013, which authorized the sale of the Purchased Assets of Seller to Buyer; and

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth below and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and subject to the conditions of the Purchase Agreement, the Parties hereto agree as follows:

1. Capitalized Terms. Capitalized terms used herein but otherwise defined in this IP Assignment shall have the meanings ascribed to them in the Purchase Agreement.

2. Assignment. Effective as of the date hereof, Seller hereby irrevocably and unconditionally sells, assigns, transfers, delivers, and conveys to Buyer all of Seller's right, title and interest in and to the Intellectual Property Rights of Seller set forth on Exhibit 1 hereto, the "iGPS" name, logos and goodwill as well as all rights associated therewith including all other corresponding rights that are or may be secured under the laws of the United States, any jurisdiction thereof, any foreign country or any multinational jurisdiction now or hereafter in effect, the same to be held by Buyer for Buyer's own use and enjoyment, and for the use and enjoyment of Buyer's successors and assigns and other legal representatives, together with all rights to income, royalties and license fees deriving from the Intellectual Property Rights of Seller, the "iGPS" name, logos and goodwill, all claims for damages by reason of past, present and future infringements or unauthorized uses of the Intellectual Property Rights of Seller, the "iGPS" name, logos and goodwill and the right to sue for and collect such damages, as permitted under the applicable laws of any jurisdiction or country in which such claims may be asserted for the use and benefit of Buyer and each of Buyer's successors, assigns and other legal representatives.

3. Assistance. Seller and Buyer shall execute and deliver such instruments and take such other actions as may reasonably be required in order to carry out the intent of this IP Assignment and to evidence and effectuate the transactions contemplated herein.

4. Relation to Purchase Agreement. This IP Assignment is expressly made subject to the terms and conditions of the Purchase Agreement. The delivery of this IP Assignment shall not affect, alter, enlarge, diminish or otherwise impair any of the representations, warranties, covenants, conditions, indemnities, terms or provisions of the Purchase Agreement, which shall survive the delivery of this Agreement to the extent, and in the manner, set forth in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

5. General.

5.1 Severability; Amendment. Any provision in this IP Assignment which is illegal, invalid or unenforceable shall be ineffective to the extent of such illegality, invalidity or unenforceability, without affecting in any way the remaining provisions hereof. This IP Assignment may not be amended except by execution and delivery of an instrument in writing signed by officers of Seller and Buyer on behalf of Seller and Buyer respectively.

5.2 Entire Agreement; No Third-Party Beneficiaries. This IP Assignment, including the Exhibits and other documents attached or referred to herein, which form a part hereof, embodies the entire agreement and understanding of the Parties, and supersedes all prior or contemporaneous agreements or understandings (whether written or oral) among the Parties, in respect to the subject matter contained herein. If any conflict exists between the terms of this IP Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and control. This IP Assignment and the obligations hereunder are not intended to confer any rights or remedies to any third party and are not intended to operate, in anyway, as an agreement for the benefit of any third party.

5.3 Successors and Assigns. This IP Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns.

5.4 Governing Law. This IP Assignment shall be governed by and construed and enforced in accordance with the Laws of the State of New York, except to the extent that such Laws are superseded by the Bankruptcy Code.

5.5 Counterparts. This IP Assignment may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument. Counterparts of this IP Assignment (or applicable signature pages hereof) that are manually signed and delivered by facsimile or other electronic transmission shall be deemed to constitute signed original counterparts hereof and shall bind the parties signing and delivering in such manner.
