Pursuant to the provisions of the Connecticut Business Corporation Act, the undersigned, on behalf of BIC Corporation, a New York corporation, and BIC Corporation, a Connecticut corporation, respectively, with respect to the merger of BIC Corporation, a New York corporation, into BIC Corporation, a Connecticut corporation, hereby certify as follows:

1. The name and state of organization of each of the constituent business entities participating in the merger herein certified are as follows:

(i) BIC Corporation, which is a corporation incorporated under the laws of the State of New York (the "Merging Corporation"); and

(ii) BIC Corporation, which is a corporation incorporated under the laws of the State of Connecticut (the "Surviving Corporation").

2. An Agreement and Plan of Merger dated as of December 19, 2005, between the Merging Corporation and the Surviving Corporation (the "Plan"), has been duly approved by the written consent of the sole shareholder of the Surviving Corporation in accordance with the provisions of Sections 33-698 and 33-817 of the Connecticut Business Corporation Act.

3. The Plan and the performance of its terms were duly authorized by all action required by the New York Business Corporation Law, the law under which the Merging Corporation is incorporated, and by the Certificate of Incorporation, as restated, of the Merging Corporation.

4. The Surviving Corporation in the merger herein certified is BIC Corporation, a Connecticut corporation, which will, upon effectiveness of the merger, continue its existence as said Surviving Corporation pursuant to the provisions of the Connecticut Business Corporation Act under the name:

5. The merger herein certified shall be effective at the close of business on the date of filing of this Certificate of Merger.


