**IP SUPPLEMENT  
(TRADEMARKS)**

This IP SUPPLEMENT, dated as of November 4, 2013 is delivered pursuant to and supplements (i) the Amended and Restated Security Agreement, dated as of August 31, 2012 (said Amended and Restated Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Security Agreement"), among Kemin Industries, Inc., an Iowa corporation, Kemin Foods, L.C., an Iowa limited liability company, and Kemin Holdings, L.C., an Iowa limited liability company (collectively "Grantor"), and Bank of America, N.A., a national banking organization, as Collateral Agent, and (ii) the Grant of Trademark Security Interest dated as of May 31, 2011 (the "Grant") executed by Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.

Grantor grants to Collateral Agent a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral set forth on Schedule 1 annexed hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grant.
