TRADEMARK ASSIGNMENT

This Trademark Assignment is made effective this 12th day of November 2013 between Perfectly Me, LLC ("Assignor") and Raquel Whiting Gilmer ("Whiting Gilmer") ("Assignee").

WHEREAS, Assignor, a Maryland limited liability company which had its principal offices at 2400 Boston Street, Baltimore, MD 21224, is the listed owner of the following U.S. Trademark Registration:

- Series of fiction books, self help books for women and girls in the field of self acceptance and self esteem, essay collections in the field of self-help designed for women and girls, illustrated books, photo books, calendars, stationery, photographs, greeting cards, cartoon books, comic strips, magazines featuring self-help for women and girls, book binding materials, books in the fields of educational training, self help designed for women and girls, blank journal books, diaries, day planners, stickers, workbooks directed to building the self-esteem of girls, children's story books, pens, pencils, markers, highlighters, and crayons, in International Class 16
- Clothing, namely, shirts, pants, jackets, coats, t-shirts, sweatshirts, hats, underwear, caps, visors, International Class 25
- Entertainment services, namely, continuing programs about self-help and motivational empowerment accessible by radio, television, satellite, audio, video and computer networks; production of television programs, films, videos, and dvds, featuring issues related to self help, self empowerment, and self acceptance; entertainment services in the nature of on-going television programs in the field of children's entertainment; educational services, namely, developing curriculum for others in the field of self acceptance, self help, and self esteem; conducting classes, meetings, conferences and workshops in the field of self acceptance, self help, and self esteem related issues; publication of online magazines, in International Class 41.

WHEREAS, Assignee, an individual residing at 5713 N. Charles Street, Baltimore, MD 21210, is the sole member of Assignor;

WHEREAS, Assignor's charter was forfeited by the Maryland State Department of Assessments and Taxation on October 2, 2009, and by operation of law, its assets, including the Mark, were transferred to its sole member, the Assignee;

WHEREAS, Assignor, wishes to record and/or confirm the transfer of all its rights, title and interest, including the good will of the business to its sole member, and all other rights inuring from use of the Mark and from the date of first use of the mark, to the Assignee.




