**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (the "Termination and Release") made as of the 25 day of October 2013 by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent pursuant to the Credit Agreement ("Collateral Agent") in favor of ICG ADDCAR SYSTEMS, LLC ("Pledgor").

A Trademark Security Agreement with a Schedule I attached thereto (collectively "Agreement"), dated September 30, 2004, by Pledgor in favor of Collateral Agent, the Agreement incorporated herein by reference, granted a security interest in specified trademark collateral, including United States trademark registration no. 1,795,602, for the trademark ADDCAR, that Trademark Security Agreement recorded with the U.S. Patent and Trademark Office at Reel 2974, Frame 0068, on November 11, 2004.

In consideration of the premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree that the Collateral Agent, for the benefit of the secured parties, does hereby release and terminate all collateral pledges, grants, assignments, and liens and security interests in the pledged trademark collateral specified in the Agreement, including United States trademark registration no. 1,795,602.
