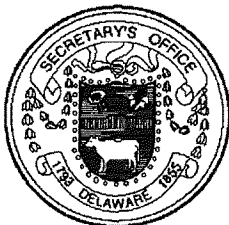

"The name of the corporation is De Nora Tech, Inc."


Sixth: That the executed Agreement of Merger is on file at the principal place of business of the surviving corporation, the
