RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of 11-08-13 (this "Release") is made by Comerica Bank, as Agent, a Texas banking association, formerly a Michigan banking corporation (the "Secured Party"), under the Security Agreement dated as of May 30, 2006 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Durakon Industries, Inc., a Michigan corporation (the "Debtor") and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 3158, Frame 0990.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
