**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of October 22, 2013, is made by WAYZATA INVESTMENT PARTNERS LLC, as Collateral Agent for the Lenders under the Security Agreement (in such capacity, the "**Agent**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement, as applicable.

**WHEREAS**, in connection with that certain Subordination and Intercreditor Agreement, dated as of November 25, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), by and between Portola Packaging, Inc., a Delaware corporation together with certain subsidiaries of Portola Packaging, Inc. (collectively, the "**Grantor**"), and the Agent, for the benefit of the Lenders, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Grantor granted security interests in certain intellectual property owned by the Grantor, including, without limitation, those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;


**NOW THEREFORE**, the Agent hereby releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Security Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Grantor.

The Agent agrees, at the expense of the Grantor, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required to effect the release of the Agent's security interests in the Intellectual Property Collateral.


