





All Intellectual Property Rights used by the Sellers in connection with the Business set forth on Section 1.01(h) of the Disclosure Schedule, including all goodwill associated therewith, to the extent assignable in accordance with applicable Law (the "<u>Assigned Intellectual Property</u>");
