**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of November 8, 2013 (this "Release"), is made by Goldman Sachs Credit Partners L.P., as collateral agent (in such capacity, "Agent") under the Pledge and Security Agreement referenced in the Trademark Security Agreement described below, in favor of Exopack Technology, LLC, Cello-Foil Products, Inc., TPG Enterprises, Inc., and TPG (US), Inc. (collectively, the "Grantors") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement by and between Grantors and Agent, dated October 13, 2005, and recorded with the United States Patent and Trademark Office on October 24, 2005 at Reel/Frame No. 3245/0339, the Grantors granted Agent a security interest on certain collateral pledged by the Grantors described therein, including without limitation the trademark registrations set forth in Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantors have paid all of their outstanding indebtedness to Agent; and

WHEREAS, the Grantors have requested that the Agent release its security interest in and lien on the Trademark Collateral.


NOW, THEREFORE, Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and all right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide the Grantors with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the released Trademark Collateral without recourse, representation or warranty and at the Grantors' sole cost and expense.


