GRANT OF SECURITY INTEREST
IN TRADEMARKS

November 13, 2013

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, each of the undersigned (each individually, a "Grantor" and, collectively, the "Grantors"), hereby grants Salus Capital Partners, LLC, having an office at 197 First Avenue, Suite 250, Needham, Massachusetts 02494, in its capacity as collateral agent for certain secured parties, as pledgee, assignee and secured party (in such capacities and together with any successors in such capacities, the "Collateral Agent"), a continuing security interest in and lien upon the following (except as such may be considered Excluded Property under the Security Agreement): (i) all of such Grantor's right, title and interest in, to and under the trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locations (URLs), domain names, corporate names and trade names, whether registered or unregistered, owned by or assigned to such Grantor and all registrations and applications for the foregoing (whether statutory or common Law and whether established or registered in the United States or any other country or any political subdivision thereof) set forth on Schedule A attached hereto (collectively, the "Marks"); (ii) any and all reissues, continuations, extensions and renewals thereof; (iii) any and all income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including, without limitation, damages, claims and payments for past, present or future infringements thereof; (iv) any and all rights corresponding thereto throughout the world; and (v) any and all rights to sue for past, present and future infringements thereof.

THIS GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Grant") has been granted in conjunction with the security interest granted to the Collateral Agent under the Security Agreement by and among the Grantors, Collateral Agent, and others, dated as of November 13, 2013 (as amended, restated, supplemented and/or modified from time to time, the "Security Agreement"). Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.


This Grant is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors. The rights and remedies of the Collateral Agent with respect to the




