TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, ROMA FOODS OF OKLAHOMA, INC. and FIESTA HOLDINGS, LLC (collectively "Grantors") entered into that certain Trademark Collateral Security Agreement dated as of June 1, 2010 (the "Security Agreement"), between the Grantors and Cratos Capital Management, LLC ("Cratos"), a true and correct copy of which was recorded by the United States Patent and Trademark Office on June 14, 2010, at Reel 4224 Frame 0210 with respect to the trademark registrations identified in Schedule A hereto;

WHEREAS, pursuant to that certain Assignment and Assumption dated December 22, 2011, Cratos assigned all right and title under the Security Agreement as well as the underlying Secured Loan to INTENSO, LLC, an Oklahoma limited liability company ("Secured Party");

WHEREAS, the Secured Party desires to record its release of its security interest in the Trademarks and termination of the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:


1. releases and reassigns to the Grantors any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the trademarks more fully described on Schedule A, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.



