

THIS CERTIFICATE OF CONVERSION relates to the conversion of Wyse Technology Inc., a corporation organized and existing under the laws of the State of Delaware (the "Company"), to a Delaware limited liability company pursuant to Section 18-214 of the Delaware Limited Liability Company Act and Section 266 of General Corporation Law of the State of Delaware. The Company does hereby certify as follows:

FIRST: The name of the Company is "Wyse Technology Inc."

SECOND: The Company was initially incorporated in the State of Delaware on June 28, 1988 and was incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion.

THIRD: The name of the limited liability company into which the Company shall be converted as set forth in its certificate of formation is "Wyse Technology L.L.C."
