Pursuant to the provisions of Section 251 of the General Corporation Law of the State of Delaware (the "DGCL"), eBay Inc., a Delaware corporation ("eBay"), hereby certifies the following information relating to the merger (the "Merger") of Hunch Inc., a Delaware corporation, with and into eBay:

**FIRST:** The names and states of incorporation of the constituent corporations in the Merger are:

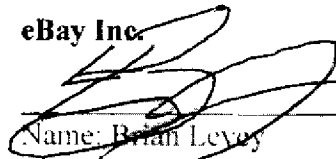
