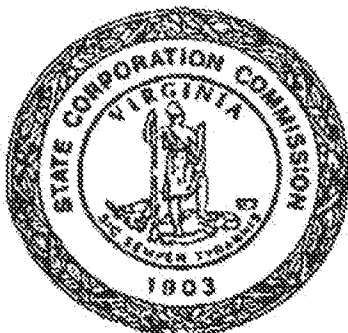

TMA RESOURCES, INC., a corporation organized and existing under and by virtue of the Virginia Stock Corporation Act (the "Company"), DOES HEREBY CERTIFY:

FIRST: The Board of Directors (the "Board") of the Company, by unanimous written consent, duly adopted and approved of resolutions setting forth a proposed amendment to the Company's Articles of Incorporation, declaring the proposed amendment to be advisable and submitting it to the shareholders of the Company for their consideration.
