ASSIGNMENT


Now, for good and valuable consideration, the receipt thereof which is hereby acknowledged, and intending to be legally bound hereby, the parties agree as follows:

1. ASSIGNORS do hereby sell, assign, transfer and set over to the ASSIGNEE the aforementioned MARK the goodwill of the business symbolized by said MARK, together with any application for registration related thereto. The same to be held and enjoyed by ASSIGNEE for its own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by the said ASSIGNORS if this assignment and sale had not been made. These rights are assigned together with all claims by ASSIGNORS for damages by reason of past infringement of the said MARK, with the right to sue for, and collect the same for her own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives.
2. ASSIGNORS will, by their legal representatives or other persons duly authorized, communicate to ASSIGNEE or the representatives thereof any facts known to them respecting

said MARK, and will, upon request, testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said ASSIGNEE or by counsel for ASSIGNEE, to assist or enable said ASSIGNEE to obtain and enforce full benefits from the rights and interests herein assigned. ASSIGNORS additionally agree to execute copies of this assignment or portions thereof regarding any or all of the aforementioned MARK, as required by ASSIGNEE in the future.

3. ASSIGNORS of the aforesaid MARK hereby agrees to waive all rights and privileges to attack any of the MARK or the registration of any or all of the aforesaid MARK.
4. ASSIGNORS will not adopt and/or use any mark which is a colorable imitation that is likely to cause confusion with any of the MARK.
