This is to certify that the Certificate of Incorporation of Group C Communications, Inc. (herein referred to as the "Corporation") which was filed and recorded with the Department of the Treasury of the State of New Jersey on January 3, 1983, is hereby amended pursuant to the provisions of N.J. Stat. Ann. §14A:9-2 of the New Jersey Business Corporation Act."

ARTICLE I NAME OF CORPORATION

The name of the Corporation is Group C Communications, Inc.

ARTICLE II DATE OF ADOPTION AND TEXT OF AMENDMENTS

The following amendment to the Certificate of Incorporation of the Corporation (the "Amendment") was adopted by the shareholders of the Corporation (the "Shareholders") pursuant to the unanimous written consent executed on May 30, 2008.

The First Article of the Corporation's Certificate of Incorporation is amended to read in its entirety as follows:

The name of the corporation is Group C Media, Inc.

ARTICLE III APPROVAL OF AMENDMENTS

The Corporation has Nine Hundred Twenty Seven Thousand Four Hundred (927,400) shares of Common Stock outstanding, the holders of which are entitled to vote to approve the Amendment. Pursuant to the unanimous written consent by the Shareholders, executed on May 30, 2008, the Shareholders approved the Amendment with Nine Hundred Twenty Seven Thousand Four Hundred (927,400) shares of Common Stock voting in favor of the Amendment.
