## TRADEMARK ASSIGNMENT

WHEREAS, **Trip.com, Inc.**, a corporation duly organized and existing under the laws of the State of Delaware, United States of America, and having a place of business at 6436 South Racine Circle, Englewood, Colorado, United States of America ("Assignor"), is the owner of the trademark listed on Schedule A attached hereto and incorporated herein by reference (the "Trademark");

WHEREAS, Travelport Limited ("Travelport") has determined to offer for sale a certain percentage of the common stock of Orbitz Worldwide, Inc. NOW, THEREFORE, in consideration of the foregoing and the covenants and agreements set forth herein, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound hereby, agree as follows:

Assignor does hereby transfer and assign to Orbitz Worldwide LLC ("Assignee") all of Assignor's worldwide right, title and interest in, to and under the Trademark, together with the goodwill of the business associated therewith and which is symbolized thereby, all of Assignor's rights to sue for infringement of the Trademark, whether arising prior to or subsequent to the date of this Assignment of the Trademark, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and/or in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of the Trademark not been made.
