Release of Lien on Trademarks

November 22, 2013

Reference is made to that certain Intellectual Property Security Agreement Supplement, dated as of January 13, 2012 (the “**Trademark Security Agreement**”) by NEXTAG, INC., a Delaware corporation (the “**Grantor**”), in favor of DEUTSCHE BANK TRUST COMPANY AMERICAS, as collateral agent (the “**Collateral Agent**”);

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded with the United States Patent and Trademark Office (the “**USPTO**”) on October 28, 2013 on reel 005140 frame 0194 and on October 30, 2013 on real 005142 and frame 0341, the Grantor granted to the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all trademarks and trademark applications of such Grantor listed on Schedule A attached hereto;

WHEREAS, the Collateral Agent desires to release its lien on and security interest in and to all of the right, title and interest in the trademarks and trademark applications of the Grantor set forth on Schedule A attached hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent does hereby agree as follows:

SECTION 1. *Release of Security Interest in Trademark Collateral.* The Collateral Agent hereby releases and terminates its lien on and security interest in and to all of its right, title and interest in, to and under all trademarks and trademark applications of the Grantor set forth on Schedule A hereto and reassigns to the Grantor all right, title and interest of the Collateral Agent in and to such trademarks and trademark applications.

SECTION 2. *Recordation of Release.* The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks in the USPTO, and any other necessary United States government officer, record this Release of Lien on Trademarks.


