## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Termination and Release") is granted as of November ~~22~~, 2013 by **WEBSTER BUSINESS CREDIT CORPORATION**, a New York corporation ("WBBC"), individually, as lender under the Credit Agreement and as agent for itself and each other Lender Party (WBCC, acting in both such capacities, herein called "Lender"), in favor of **SKIP HOP, INC.**, a New York corporation (the "Company").

### WITNESSETH:

WHEREAS, the Company is a party with the Lender and each other Lender Party to a Credit and Security Agreement dated as of April 26, 2013 (as amended, supplemented, extended, restated, or otherwise modified prior to the date hereof, the "Credit Agreement") pursuant to which the Lender and the Lender Parties agreed, among other things, to extend certain credit accommodations to Company under the terms and conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, the Company executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement") granting the Lender a security interest in and lien on certain Trademarks (used herein as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 14, 2013, at Reel 5047, Frame 0229, against certain Trademarks identified on Schedule 1 hereto;

WHEREAS, the Company has requested that the Lender provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby releases and discharges its liens and security interests in the Trademarks, including but not limited to those Trademarks identified on Schedule 1, together with all products and proceeds thereof, including without limitation, any claims by the Company against third parties for past, present or future infringement of any Trademark.
