RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL

This RELEASE, dated as of November 25, 2013, is made by BANK OF AMERICA, N.A., as Agent ("Agent") under that certain Loan and Security Agreement, dated as of July 23, 2010, between Humanities Innovative Solutions, Inc., formerly Safety Technology Systems, Inc. (the "Grantor"), and Agent (as amended, amended and restated or otherwise modified from time to time, the "Loan Agreement").

WHEREAS, the Grantor has requested that the Agent terminate and release its security interest in all of its right, title and interest in and to its Trademarks, including those trademarks set forth in Schedule I.



The Agent agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of the Agent's security interest in the Trademarks.


