RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of November 26, 2013 (this “Release”) is made by Wells Fargo Bank, National Association, as Collateral Agent (in such capacity, the “Collateral Agent”) for each of the Secured Parties (as defined in the Grant of Second Lien Security Interest in Trademark Rights referenced below) under that certain Grant of Second Lien Security Interest in Trademark Rights, dated as of April 8, 2010, and recorded April 12, 2010 in the records of the United States Patent and Trademark Office, at Reel 004184/Frame 0414 (as amended, supplemented or modified and in effect prior to the date hereof, the “Agreement”), between Maxim Crane Works, L.P., a Pennsylvania limited partnership (the “Obligor”), and the Collateral Agent;

W I T N E S S E T H:

WHEREAS, pursuant to the Agreement which was recorded in the records of the United States Patent and Trademark Office, the Obligor granted to the Collateral Agent a security interest in the Collateral (as defined in the Agreement) including those set forth on Schedule A attached hereto;

WHEREAS, the Collateral Agent wishes to: (i) terminate the Agreement against the Collateral including those identified in Schedule A attached hereto, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest in the Collateral including those listed in Schedule A attached hereto; (iii) restore all right, title and interest in and to the Collateral including those listed in Schedule A attached hereto, to Obligor; and (iv) to dissolve any and all liens and encumbrances granted to it by Obligor respecting the Collateral including those listed in Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release its security interest in the Collateral including those set forth on Schedule A attached hereto, discharges, quitclaims and relinquishes unto Obligor (in each case without recourse and without any representation or warranty) any and all rights, title and interest Collateral Agent has in and to the Collateral and the security interest granted to Collateral Agent in the Collateral including those listed in Schedule A attached hereto, and authorizes Obligor to record this Release with the United States Patent and Trademark Office.
