FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted the resolution set forth below proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Board propose to the Shareholder and declare advisable that the Certificate of Incorporation for the Corporation be amended by changing the first Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

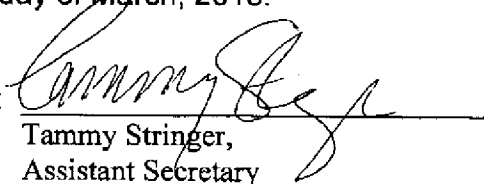
"FIRST: The name of the Corporation is BB&T Insurance Holdings, Inc."
