**NOTICE OF TRADEMARK SECURITY INTEREST**

This Notice of Trademark Security Interest, dated as of November 25, 2013, is made with regard to Winderosa Manufacturing and Distributing Company, USA, Inc., a Maine corporation ("Winderosa"), Arrowhead Electrical Products, Inc., a Delaware corporation ("Arrowhead"), Total Power Solutions, Inc. (f/k/a DB Electrical, Inc.), a Delaware corporation ("Total Power") and Associated Bank, National Association, as Administrative Agent ("Agent"), all having addresses for notice on the attached schedule, and certain lenders.

R E C I T A L S:


Winderosa, Arrowhead, Total Power and their affiliates, AEP Holdings, Inc. and All Balls Racing, Inc. (collectively, the "Borrowers"), the Agent and the lending financial institutions named therein (the "Lenders") are parties to the Amended and Restated Credit Agreement dated as of August 1, 2012, as amended (as the same may hereafter be further amended, supplemented or restated from time to time, the "Loan Agreement") setting forth the terms on which the Lenders may now or hereafter make certain loans or other financial accommodations to or for the account of the Borrowers. The obligations of the Borrowers are secured by substantially all personal property of the Borrowers, including, without limitation, certain trademarks of Winderosa, Arrowhead and Total Power, pursuant to the terms of the Amended and Restated Security Agreement among the Borrowers and the Agent dated as of August 1, 2012 (as amended, supplemented or restated from time to time, the "Security Agreement").

ACCORDINGLY, in consideration of the mutual covenants contained in the Loan Agreement, and herein, the undersigned gives notice as follows:

Pursuant to the terms of the Security Agreement, Winderosa, Arrowhead and Total Power have granted a security interest in favor of the Lender in and with respect to the entire right, title, and interest in the trademarks identified in the attached schedule (the "Trademarks"), together with the goodwill of the business symbolized by said Trademarks.

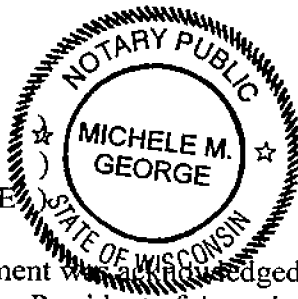


