RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of November 21, 2013 (the "Execution Date"), is executed by JPMorgan Chase Bank, N.A., a national banking association with offices at 707 Travis, 7th Floor North, Houston, Texas 77002 (the "Secured Party"), in favor of Personnel Decisions International Corporation, a Delaware corporation with offices at 33 South 6th Street, Suite 4900, Minneapolis, Minnesota 55402 (the "Company"), and certain subsidiaries of the Company, as listed on Exhibit A (the "Subsidiaries").

RECITALS

WHEREAS, the Company and Secured Party entered into a certain Credit Agreement, dated as of October 16, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Company and Secured Party entered into a certain Intellectual Property Security Agreement, dated as of October 16, 2008, and recorded with the United States Patent and Trademark Office on November 21, 2008 at Reel/Frame 3892/0176 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Company granted to Secured Party a security interest in certain collateral including intellectual property; and

WHEREAS, the Credit Agreement and the Security Agreement have been terminated.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party agrees as follows:

1. The Secured Party is executing and delivering this Release as further evidence of the termination of the Security Agreement.

2. The Secured Party claims no right, title or interest whatsoever in or to any of the collateral described in the Security Agreement, and, accordingly, the Secured Party expressly terminates, releases and discharges its security interest in the intellectual property listed on Exhibits B, C, and D hereto, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on November 21, 2008 at Reel/Frame 3892/0176.


