

TRADEMARK ASSIGNMENT AGREEMENT

2. Assignment. For valuable consideration, Assignor hereby grants, transfers and assigns to Assignee all of Assignor's right, title and interest in and to the Marks, together with the good will of the business symbolized by the Marks, and the above identified registrations thereof.

3. Miscellaneous. This Agreement shall (i) be binding on the successors, assigns and licensees of Assignor and Assignee (ii) inure to the benefit of the successors and assigns of Assignee, and (iii) be governed by and construed in accordance with the laws of the State of California.
